**John Borthwick, Senior Housing and Financial Counselor**

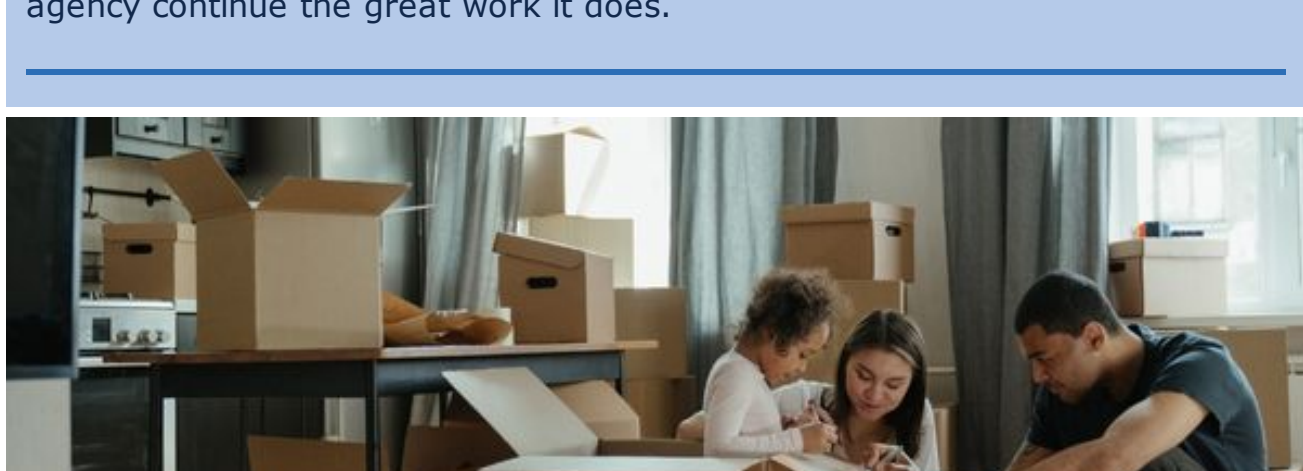
### GLCU Foundation for Financial Empowerment

After growing up on the East Coast around the Washington, D.C. area, John Borthwick moved to Chicago in 2009 after a good friend suggested giving the city a shot. John had experience in construction and quickly got a job as a carpenter doing rough framing. After a few years in the trades, he got the bug to go back to school, and earned a master's degree in public policy from DePaul University.

He primarily focused on social inequalities within housing, so when he landed a job in [HUD housing counseling](#), he was incredibly excited to start a career in something he was passionate and intellectually curious about.

For the past six years, John has been working in GLCU's Uptown Chicago branch as a HUD-certified Senior Housing and Financial Counselor at the [GLCU Foundation for Financial Empowerment](#). He started out doing only foreclosure cases and found the work and situations people had to be challenging but incredibly rewarding to solve.

He eventually began counseling in all areas of finance and loved being able to be the one responsible for guidance that helped people grow generational wealth, fix their credit, and avoid serious issues such as foreclosure, eviction, and homelessness. He's incredibly grateful for a job that allows him to interact so personally with people needing help and hopes he can help the agency continue the great work it does.
